Music Ministry: Dan Greig

Going well. Christmas season was very good. Update on the church sound system: There was a full evaluation of the sound system for the church and chapel by a professional company. To fully incorporate all the suggestions would cost up to \$400,000. This included acoustic panels. Dan reports that there will be a step approach to upgrade with a top budget of \$100,000. Will likely get a new digital mixing board and change the placement of the speakers. Dan will continue to report updates.
